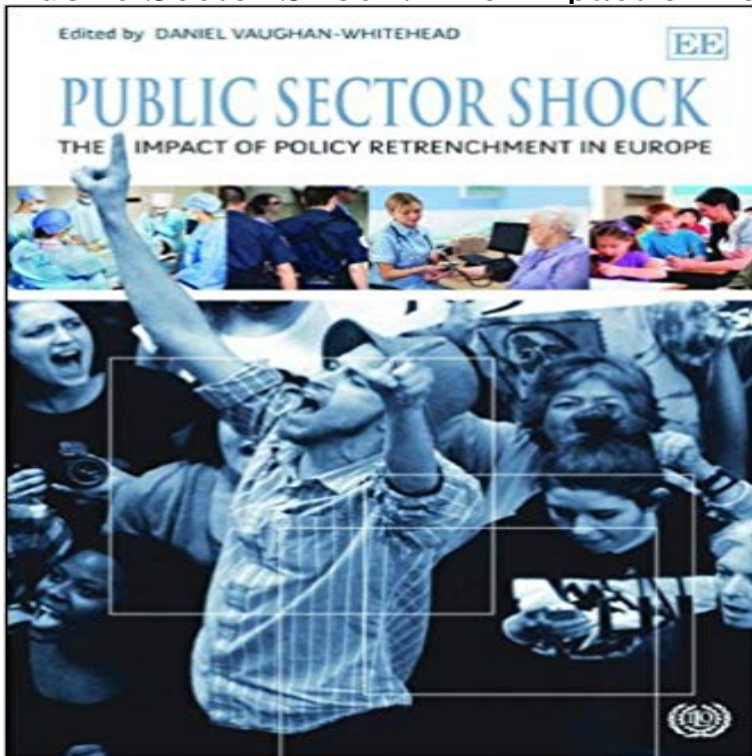


Public Sector Shock: The Impact of Policy Retrenchment in Europe
