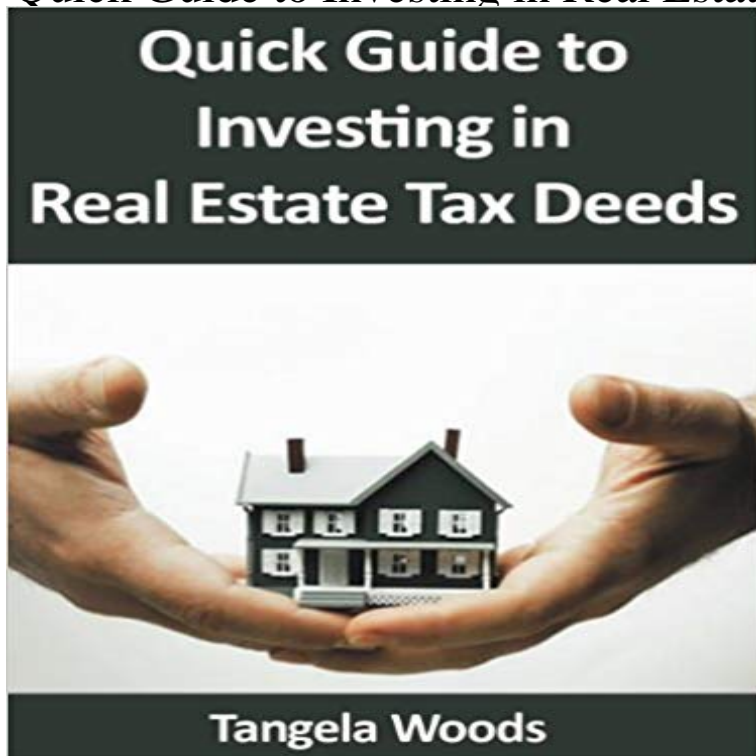


## Quick Guide to Investing in Real Estate Tax Deeds
